

## 2025 Director Notice of Nominations and Elections

The NSW Stoma Limited Board is calling for nominations for the 2025 Director election.

Four sitting directors are retiring, two are eligible to again contest for election and have indicated they intend to stand again, and there are two vacant positions due to directors retiring.

Any NSW Stoma members are eligible to nominate as a candidate for election, subject to that candidate meeting the requirements of NSW Stoma Limited's Constitution ([available on our website](#)).

Previous Board or committee experience would be highly regarded.

The NSW Stoma Board utilises online meeting software and Board management software requiring potential board members to own a computer and have sufficient computer literacy to make use of this software.

Nominations must be received in writing by the Secretary **no later than 12:00pm (AEST), 26 September 2025**. Eligibility requirements, nomination forms and further information are below and over the page.

It is a requirement that all directors undergo a police check at NSW Stoma's expense when elected.

Please also attach to your nomination form a short (250-word maximum) description of the skill set and experience you would bring to the Board and a current CV.

### Eligibility Requirements:

1. The NSW Stoma Limited Constitution states:

#### *Section 39.11*

*A person is eligible for election as a director of the company if they:*

- (a) are a member of the company and have been a member for at least twelve (12) months, or a representative of a member of the company (appointed under clause 24),*
- (b) are nominated by two members or representatives of members entitled to vote (unless the person was previously elected as a director at a general meeting and has been a director since that meeting),*
- (c) give the company their signed consent to act as a director of the company,*
- (d) must not have a criminal record,*
- (e) must have experience in business procedures along with good communications skills, and*
- (f) are not ineligible to be a director under the Corporations (New South Wales) Act 1990 No 83 or the Australian Charities and Not-for-profits Commission Act 2012 (Cth) (the ACNC Act).*

2. Section 201B of the Corporations Act 2001 provides:

- (1) Only an individual who is at least 18 may be appointed as a director of a company.*
- (2) A person who is disqualified from managing corporations under Part 2D.6 may only be appointed as director of a company if the appointment is made with permission granted by ASIC under section 206GAB or leave granted by the Court under section 206G.*
